Gandhinagar Institute of Technology SSIP-IPR Cell conducted 2 days on ‘Patent Drafting Workshop’ on 2nd and 3rd December, 2020. The workshop was organized to provide exposure to the patent drafting. This program was exclusively design for GIT Faculty members.

Program Overview:

The director has initiated patent awareness and patent drafting drive in the campus to educate faculty members. The Patent Drafting workshop was hosted and inaugurated by prof Jyotin Kateshia, IPR Cell coordinator. All the faculty Seventy faculties were attended the program. All the programs were conducted through google meet and Microsoft team.

Dr. Manish Rannch was the first speaker on the day 1 and he informed “Importance of patent and also discussed patent law in india”, where he emphasize the faculty members to go for patent of their innovative work. Mr. Amit Patel was the second speaker on day 1 and he taught about the “Prior art search” also discussed methodology to search similar patent from various patent database like USPTO, PATSEET, WIPO, INDIAN Patent Search etc. He also discussed about the payment fees of the Patent office.

Dr Anish Gandhi was the third speaker on the day 2 and he explained his session via hands on activity on “Patent Drafting Application” where he discussed example tooth brush and tooth paste dispenser. 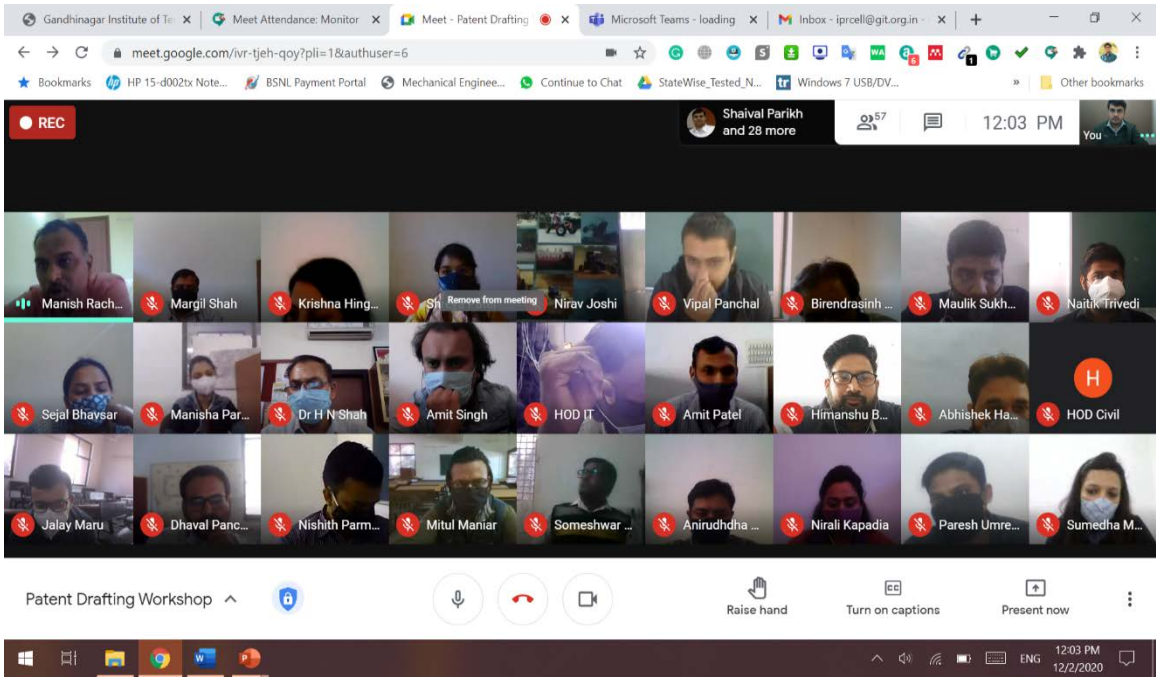

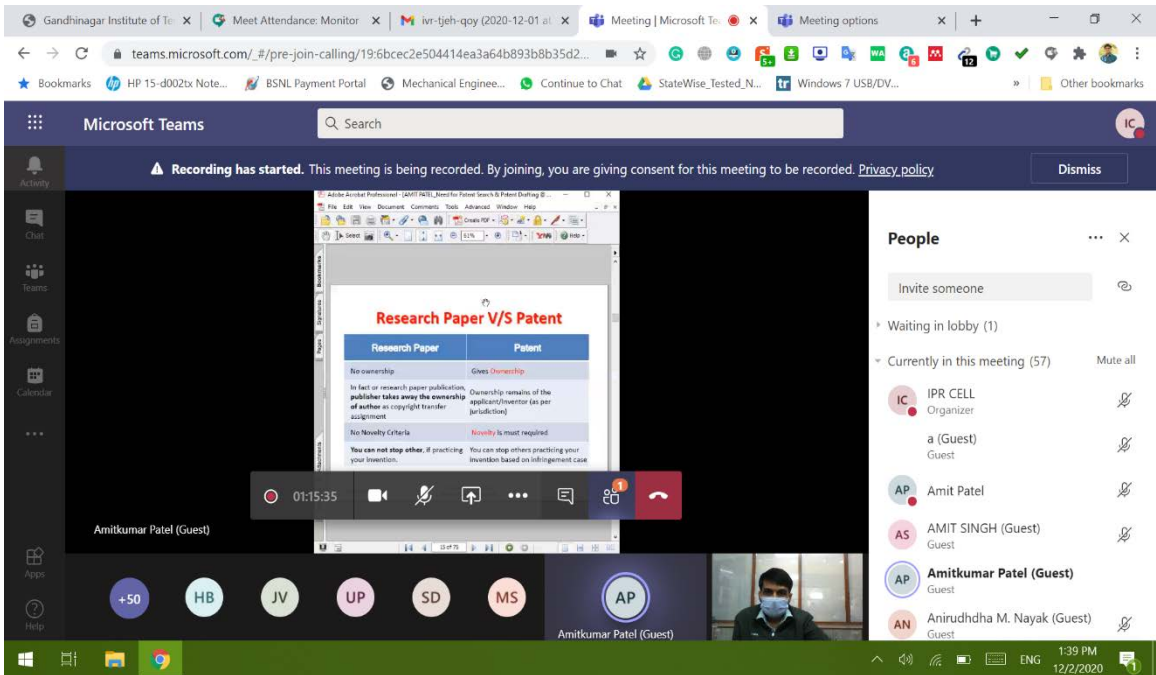

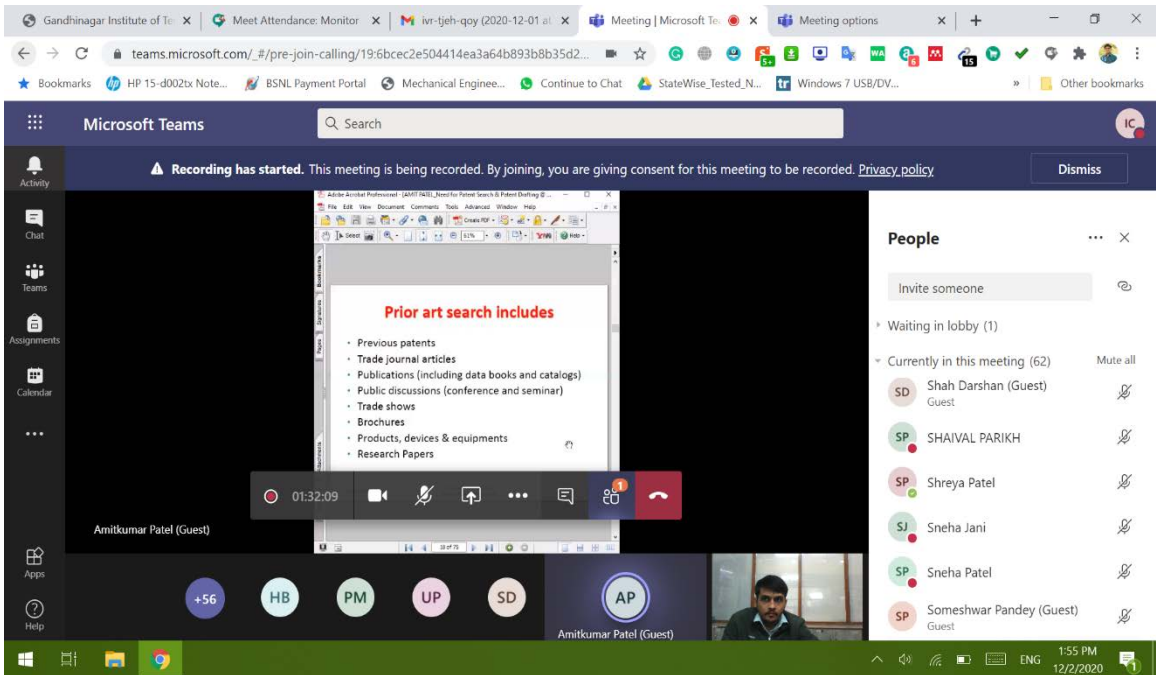
